By granting your affirmative consent, you agree that any disclosure, notice, record or other type of information that is provided to you in connection with NYMCU Online Banking Agreement ("Agreement"), or in connection with other agreements for products and services that you may open or to which you may subscribe, and any other notices that we are required by law to provide you, including any change-in-term notices, fee and transaction information, statements, federal or state-mandated brochures and disclosures, and transaction information ("Communication(s)"), may be sent to you electronically by posting the information at our web site, <u>www.nymcu.org</u>, or by sending it to you by e-mail or other form of electronic communication.

You have the option to receive this Authorization, the Agreement, other agreements for products or services to which you may subscribe through NYMCU Online Banking, and any other Communication in paper or nonelectronic form. However, we will not be obligated to provide any Communication to you in paper or nonelectronic form unless you specifically request us to do so as set forth below.

Other federal and state laws and regulations may be enacted or amended in the future to provide for electronic delivery of disclosures and notices. Your agreement to the terms of this Authorization also authorizes us, at our discretion, to provide electronic delivery of any Communications pursuant to these statutes after they become effective. If there is more than one party on the account, notice to any one account holder will be effective for all.

Your withdrawal will become effective after we have received it and had a reasonable opportunity to act on it.



In order to access, view and retain this Authorization and the Agreement, or any other Communication, you will need a computer (including a mobile device of similar capacity) with the Adobe® Acrobat® Reader® software, a working Internet connection and sufficient electronic storage capacity on your computer's hard device or other storage unit. You are responsible for the set-up and maintenance of your computer/mobile device, software and modem as well as any and all telephone access fees or Internet service fees that may be assessed by your telephone company or Internet service provider: You will also need an Internet browser that supports 128-bit encryption such as Microsoft® Internet Explorer version 6.0, Firefox 3.0, Safari 4.0 or higher. Finally, you will need to have an e-mail account with an Internet service provider and appropriate e-mail software. We may amend (add to, delete or change) these terms by providing you with advance notice.
